

## **ELIGIBILITY FOR THE COMPETITION**

### **§ 1 ELIGIBILITY**

All natural persons over the age of 16 are eligible to participate.

Excluded from participation are our employees and all persons involved in the realisation of the competition.

We reserve the right to exclude persons from participating in the competition who manipulate or attempt to manipulate the participation process, the system and/or the prize draw and/or violate the conditions of participation. If the excluded participant is a winner who has already been drawn, the prize may be subsequently cancelled and a replacement winner drawn.

### **§ 2 COMPETITION PERIOD**

The competition will be held from 01.04.2023 to 01.08.2024, 23:59.

### **§ 3 PARTICIPATION**

Participation is free of charge.

## **§ 8 LIABILITY**

This limitation does not apply to damages resulting from injury to life, limb or health or in cases of mandatory statutory liability.

## **§ 9 PREMATURE TERMINATION**

We reserve the right to cancel the competition in whole or in part at any time, even without observing deadlines, or to terminate it prematurely or to change its course if it is not possible to guarantee the proper execution of the competition for technical (e.g. computer virus, manipulation of or errors in software/hardware) or legal reasons or for reasons of force majeure. In such a case, participants are not entitled to any claims against us.

## **§ 10 MISCELLANEOUS**

Should individual provisions of the conditions of participation be or become invalid, the validity of the remaining conditions of participation shall remain unaffected. We reserve the right to change the conditions of participation at any time.
